28th Annual Fall Pumpkin Fest Parade Information

The 28th Annual Fall Pumpkin Fest will be held at Conneaut Lake Park from Friday, October 12-Sunday, October 14, 2018. **The PARADE will be held in downtown Conneaut Lake on Saturday, October 13 @ 10 a.m.**

The Fall Pumpkin Fest is sponsored by the Conneaut Lake Area Business Association.

You, your organization, group or business is cordially invited to participate in the Fall Pumpkin Fest Parade.

Deadline for entries is September 30, 2018

Parade line-up starts at 8:15 a.m.

Guidelines and information

1. Judging of the floats will be done prior to the beginning of the parade. Floats to be judged must arrive by 8 a.m. Judging will be done at 8:30 a.m. Floats must be on time for judging.
2. In light of the rising national concern regarding childhood obesity and juvenile diabetes, we are asking that you rethink handing out candy at the parade. Examples of alternative items include beads, raisins, craisins, granola or granola bars and nuts of any kind. In any case, **NO ITEMS MAY BE THROWN** by parade participants. Someone affiliated with the organization may walk along the parade route and **HAND** out the item.
3. **LINE UP starts at 8:15 a.m.** We will be utilizing Conneaut Lake Elementary School parking lots, Line Street, Fireman's Beach, 5th Street, 6th Street and some side streets.
4. The parade route is east on Water Street, turn left onto 2nd Street (Aldina Drive), and continue to Fireman's Beach to disband.
5. Use of sirens, air horns and other noise making devices should be kept to a minimum as a courtesy to other units and parade viewers.
6. Announcer and reviewing stand will be located on Water Street on the south side of Rite Aid.
7. **Bands and marching units will perform as they pass the reviewing stand.** Your performances will begin as you enter the intersection of Sheetz/1st National Bank of PA.
8. Units with animals are **REQUIRED** to have their own sanitation department (shovel & bucket) or tail bags for the courtesy of the other units and the Conneaut Lake Borough.
